Hi Doug,

Just got off the phone with Extraction and I am hoping I can clarify the issues with the water tanks. I am also happy to follow up with the survey crew to get to you a revised facility layout. At any rate, here is what I am hoping to change...

- 1.) on both the North and South pads, pls change it from 36 oil tanks to 30 oil tanks and 6 water tanks

- 2.) they do not use any buried water vaults. so the two vaults indicated on both the North and South pads sitting to the left of the tanks should be changed from 'water vaults' to 'vapor recovery towers' (there will be two on the north pad and two on the south pad)

I hope that clears up any confusion. Thanks for speaking with me,

After speaking with Extraction, the indicated facilities are correct. The part that was incorrectly explained is that the Waag Middle Pad will not simply flow back to the Waag South Pad as I previously indicated. What happened is that half of the wells on Waag Middle Pad (Wells #6-12) will flow to the Waag North NENW Pad #1 (Doc #400658916) and the other half of the wells (Wells #13-18) will flow back to the Waag South SESW Pad #1 (Doc #400658921)

I apologize for the confusion.

Seems odd that a location with only 5 wells will need 36 oil tanks, 13 separators, 2 buried produced water vaults, one gas compressor, and 4 energy conversion devices. Also, what exactly is an energy conversion device?

Nick,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) You have indicated the nearest property line is 14 feet away and have a comment indicating a signed property line waiver (603.a.2) has been secured. Please provide me with a copy of this signed waiver and I will add it to the Form 2A.

2) Due to the proximity of irrigation ditches and the Eaton Ditch to this proposed oil and gas location, I will change the Sensitive Area designation from NO to YES in the Water Resources section.

3) Due to the proximity of irrigation ditches and the Eaton Ditch to this location, I will place the following Condition of Approval on this Form 2A: "Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect the irrigation ditches and Eaton Ditch located 182 feet and 199 feet northeast and 199 feet and 256 feet northwest of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products."
