Two CIBPS were set at 6816' and 6616', both with 2 sacks of cement on top, a 5K wellhead was also added. This was done in order to isolate the producing formations during Noble's frac of their Five Rivers and Shable horizontal pads. The nearest offset wells are the Five Rivers K08-67-1HN (API: 123-39475) and the Shable K08-69HN (API: 123-39558). A form 42 has also been submitted. Wireline ticket and wellbore diagram are attached.
