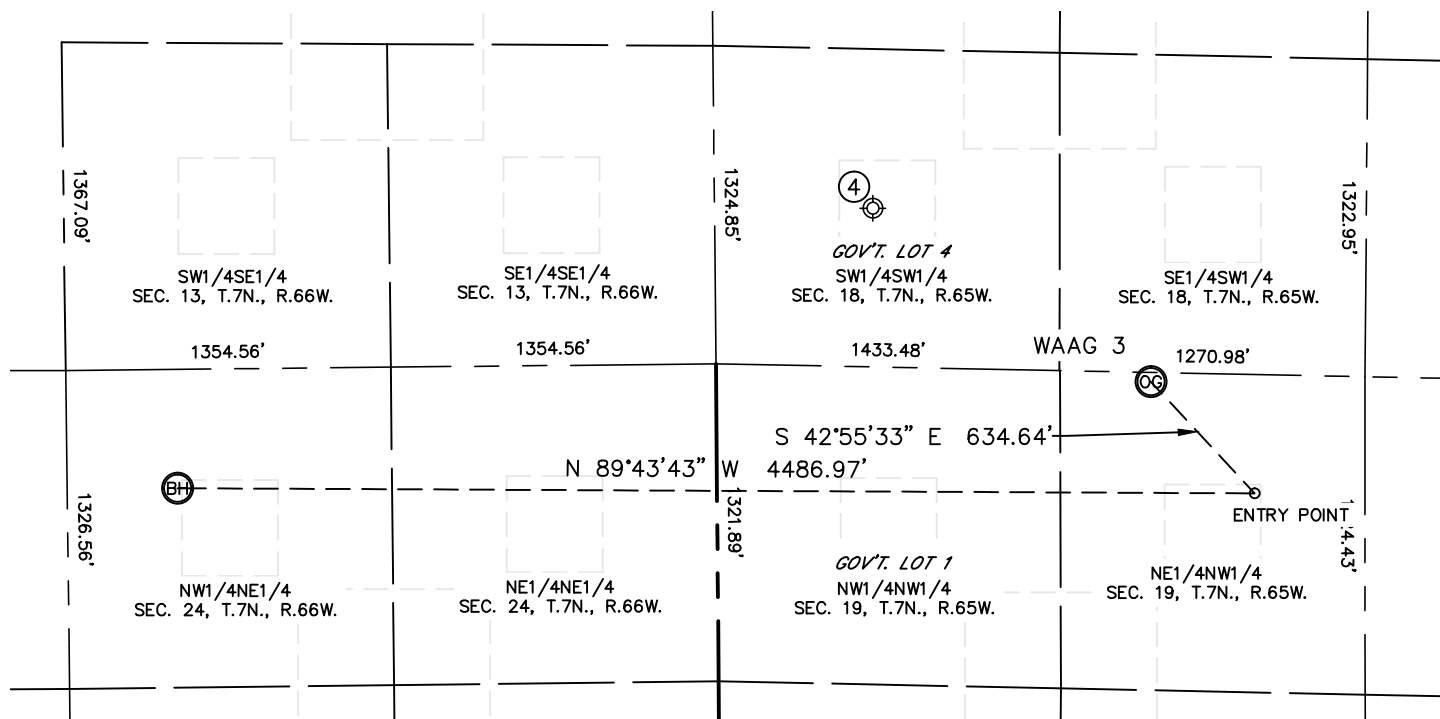

## SITE SKETCH

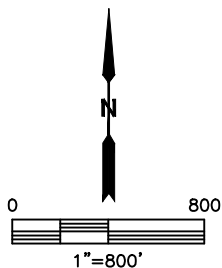
