## COMMENTS:

Ursa Operating Company (Ursa) is requesting to use cuttings stockpiled on the Burckle Cuttings Staging Area for beneficial reuse during the interim reclamation to be conducted at the site. Due to advances within Ursa's internal cuttings management operations and procedures, staging of cuttings at the site is not desired at time. The cuttings currently stockpiled on location were delivered to the site for staging under the approved Form 4 (400470923). The existing cuttings on site have been sampled and satisfy COGCC Table 910-1 standards (see attached analytical). In addition to the cuttings analysis, five (5) background samples have been collected to be used for arsenic and inorganic comparison for the surrounding area. Ursa is requesting to beneficially reuse the cuttings on-site during the Interim Reclamation efforts for this location. Reuse of the material will be within the disturbed boundary of the site.
