A follow-up (supplemental) Form 19, doc #400653801 was submitted on 7/31/2014 with confirmation sample results indicating that remediation had been completed and excavation had been backfilled. The form was approved with a note stating that No Further Action is Required. Form 19, doc #400653801 was then automatically closed.
