COMMENTS:

VAL Energy, Inc. requests to change the BOP equipment from a 3M Double Ram and Annular system, to a 2M Annular BOP only system. This change is requested due to the maximum bottom hole pressure anticipated, only being 1600 psi. Murfin Drilling Company, Rig #22 does not provide enough clearance height under the substructure to accommodate a 3M Double Ram and Annular system. Local BOP rental companies report they cannot supply the stack height required to meet the BLM specified valving, manifold, and accumulator configuration for a 3M BOP system. Therefore, due to the low bottom hole pressure projected in the drilling plan, the drilling rig configuration, and lack of equipment to meet BLM specifications, VAL feels a 2M Annular system will provide adequate protection for the drilling of this well. BLM granted approval of this change on 8/12/14.
