The SHL has changed, along with the lateral, well name, and spacing unit. Initially, Synergy was going to drill from section 16 north into section 9, however seismic revealed a large fault, which prohibited drilling in a south to north orientation. The sundried lateral has an east to west orientation, which will allow us to develop the minerals in section 9. All the revised documents are attached.

There are no offset wells within 1500' of the proposed wellbore.

Proposed Spacing Unit is 320 acres and includes the N/2 of Section 9, Township 4N, Range 68W. Synergy has 100% of the lease hold in the proposed spacing unit.
