COMMENTS:

WPX energy requests approval to set an 80-BBL blowdown tank just to the southwest of where the access road comes on to the GM 11-28 pad.

This tank had previously been planned to be set on the northern part of the pad but that would have interfered with the cuttings management area. Also, a tank pad on the MV 53-28 pad had been previously approved to hold 3-300 BBL water tanks and 3-300 BBL condensate tanks. We need the same number of tanks but now 2 of them will be for produced water and 4 will be for condensate in order to accommodate the different oil leases. See attached plat.

The wells on this pad, or permitted on this pad, are as follows – all wells in Fed lease COC 24099: GM 701-28-HN1, GM 314-21, GM 323-21, GM 23-21, GM 413-21, GM 313-21, GM 514-21, GM 321-28- CA COC046627, GM 411-28- CA COC046627, GM311-28- CA COC046627, and GM 521-28- CA COC046627.
