Comment: Rill erosion is occurring along cut slopes on the northern edge of the project area and on downstream portions of the project area (eastern edge and southeastern corner). These areas need to be monitored and stormwater BMPs applied if erosion worsens. Woody debris placed in channel will not likely be sufficient to de-energize and filter stormwater flows in the erosional channels. See attached photos.
