- 2) After plug set and/or casing pressure test is complete, commence with LOE annular fill procedure below.
- 3) Bleed off bradenhead, unland casing.
- 4) RIH 1 1/4" tubing down annulus w/ mule shoe to approx. 1250'. Condition hole.
- 5) RU cement crew, pump 347 sx cement w/ gas check, bringing cement to approx 687'
- 6) POOH w/ 1 1/4" tubing to 737'. Reverse circulate out until no returns of cement at surface.
- 7) POOH w/ 1 1/4" tubing. Re-land casing.
- 8) SI well & WOC (at least 4 hours, but preferably overnight). Run CBL, recording new cement depths.
- 9) Clean out hole.
- 10) RDMO.
