COMMENTS:

The well will be shut-in and non-producing for a period of 18 to 24 months. 'It is requested this well is changed to a 'monitoring well' because there is a permanent gauge downhole monitoring both pressure and temperature. This gauge is located beneath a swell packer approximately 2-3 jts from the Niobrara production interval. This well also has production tubing with an XN and bridge plug installed at the end of tubing. The gauge cable is run along the outside of the tubing to surface. Pressures and temperatures have been monitored via these gauges since their installation. Since these are permanent downhole gauges and have been installed to monitor temperatures and pressures throughout a well's life, it is requested that this well status be changed to 'monitoring'.'
