Inspector Comment:

Reclamation is in process. Pad surface has been reseeded and grass is starting to grow. A pond has been constructed on the northwest side of the pad at about 90 feet of the well. Note: A metal detector was used to identify the well location. The metal detector identified two metal spots: One that closely matches the as built well location (30 feet East of the pond), and another spot located toward the eastern border of the pad. Topographically, the pond is at a lower elevation (about 9 feet lower) than the well ground surface. A little bit of water was observed at the bottom of the pond. Two seeps on the northwest wall of the pond (Just some standing water). No water was observed flowing from the seeps into the pond. No hydrocarbon odor was detected and no sheen was observed. A white crust (mineral deposition) was observed near the seeps. Moist soil and green vegetation upslope of the pond near the Northwest corner of the pad.
