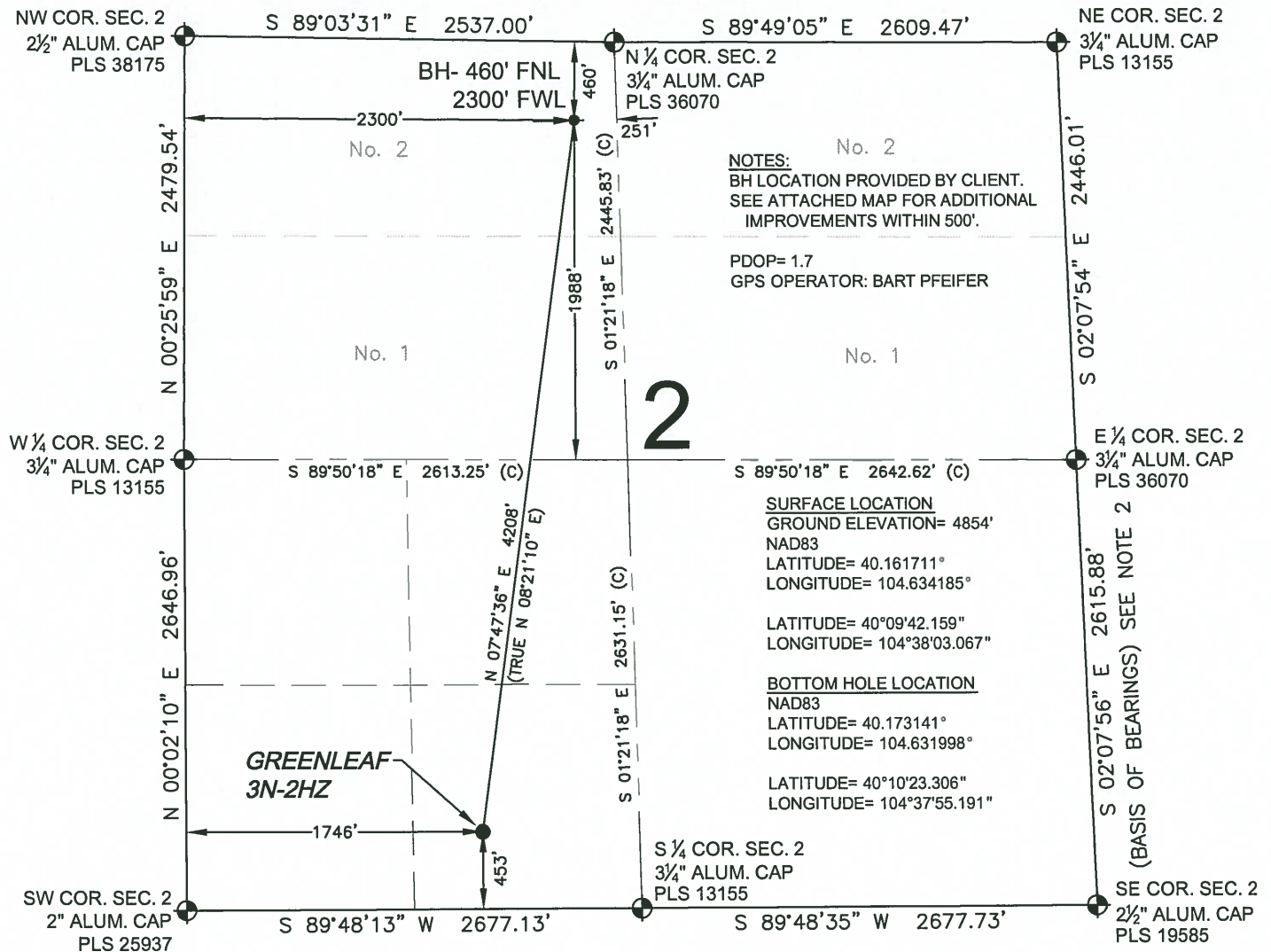


WELL LOCATION CERTIFICATE: GREENLEAF 3N-2HZ

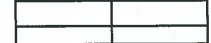

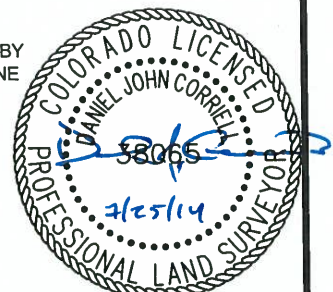

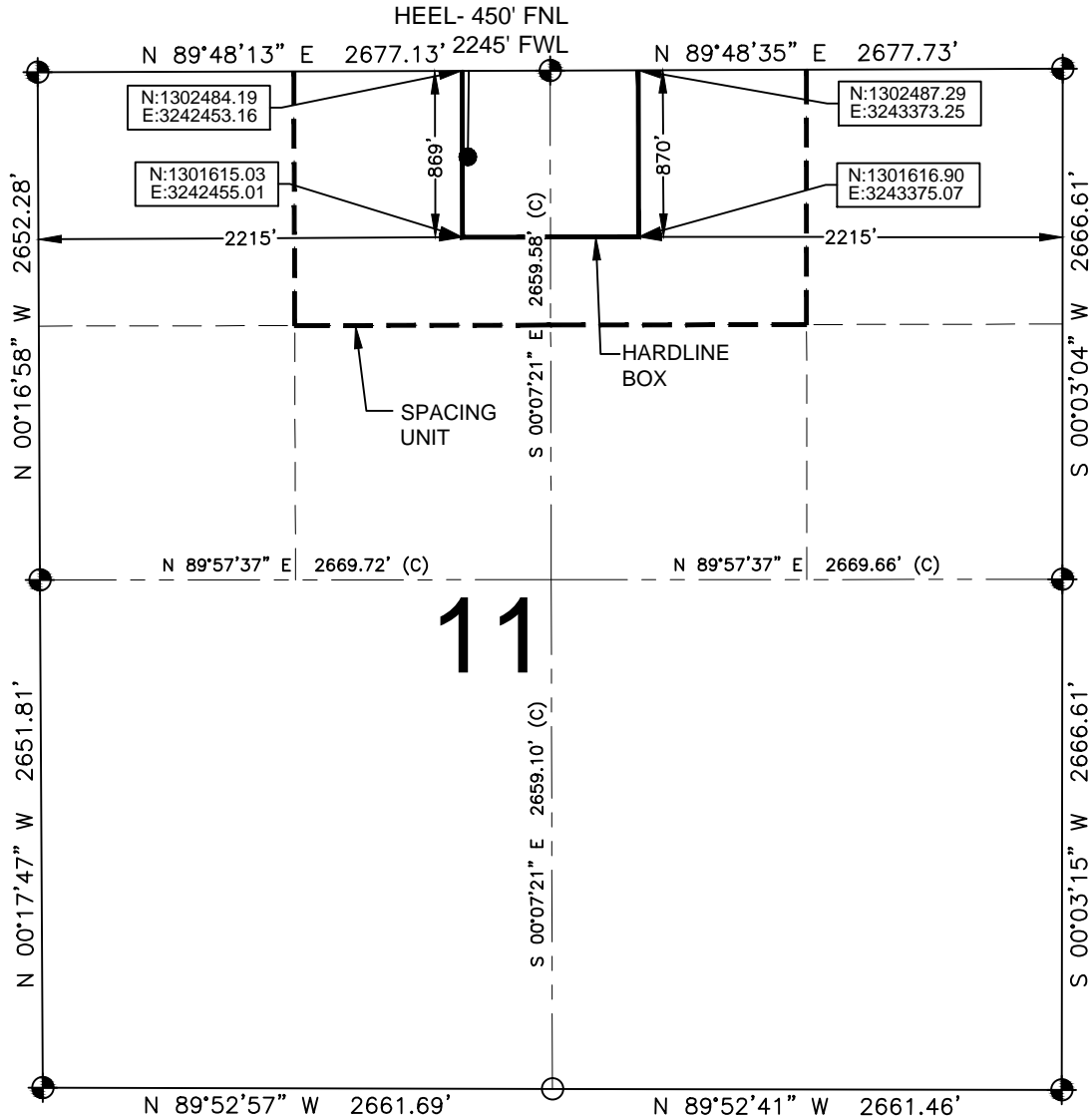
