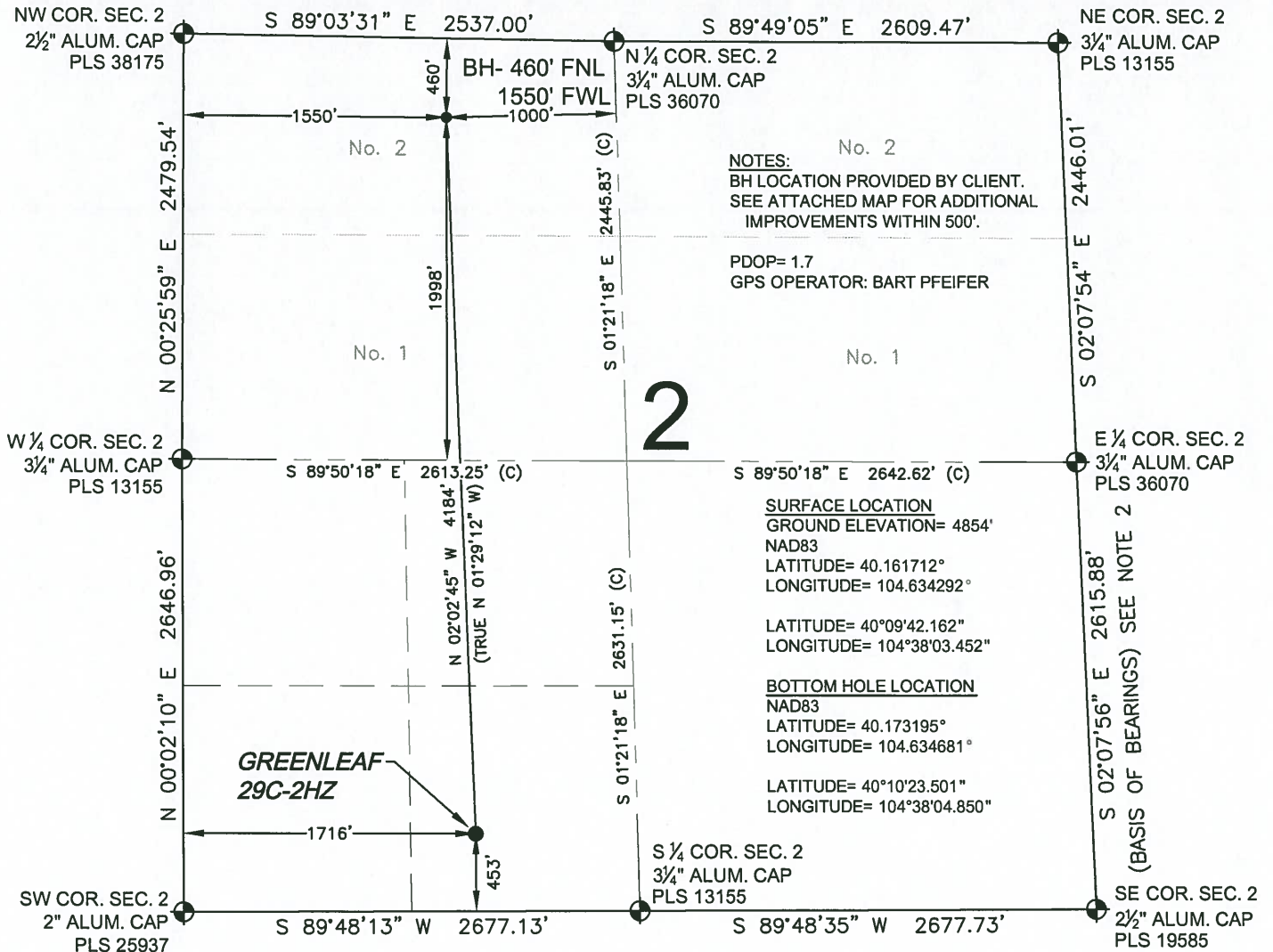


WELL LOCATION CERTIFICATE: GREENLEAF 29C-2HZ

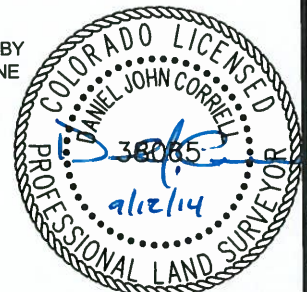

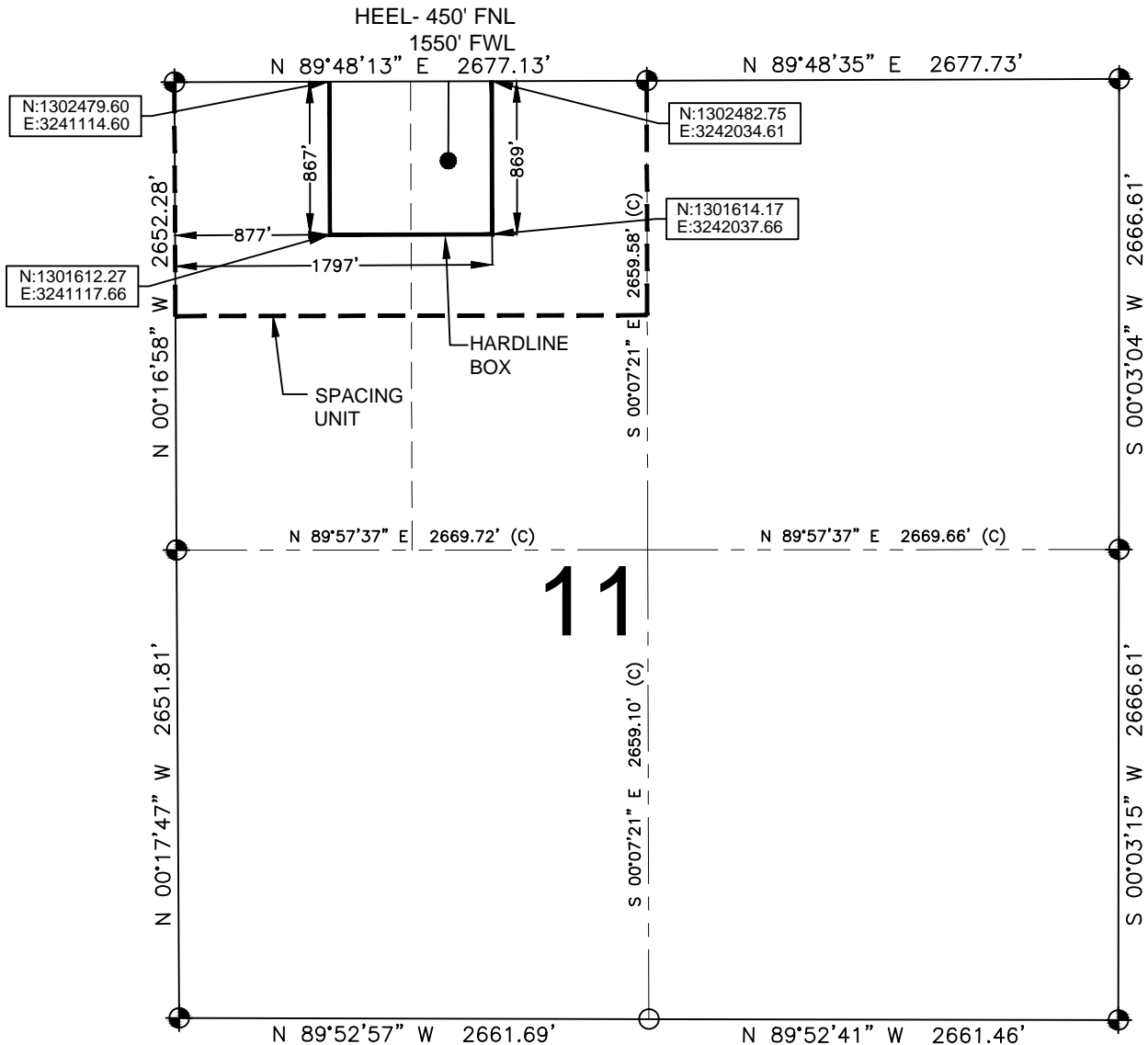
