COMMENTS:

VAL Energy has consulted with Colorado State employee Peter Gintautas, the drilling contractor, Jack Reecer of Wildcat Drilling of Cheyenne Wells, and Bill Tainor the surface owner as to the following.

1. Install cattle panels to set the entrance back as proposed off Road U, but do not install cattle guards until production is established.
2. Flat blade the trail to create a 14 ft wide road across Mr. Trainor's land to the location. Fill holes with rock and possible installation of one culvert as needed
3. Build location with a berm around the east, west, and south sides to eliminate run off. No pits will be constructed.
4. Set two frack tanks to store the trucked in water for drilling.
5. Use steel working pits with a shaker to separate cuttings from the mud and let cuttings fall onto an above ground plastic lined and bermed area, then spread cuttings on location to dry.
6. Jet mud from steel working pits into above ground steel holding tanks, then suck mud up by vacuum truck and spread on Mr. Trainor's land where bare and wind erosion is occurring per Mr. Tainor.
7. Once the well is proven productive, set production facilities and berm per existing plan. Build road to BLM specifications.

All the above have been approved by Peter Gintautas, Jack Reecer and Bill Tainor.
