Cholla Production Field Representative met with Landowner, Mitch Cogburn, at referenced well site on Oct.2, 2014. The plan is to comply with landowners request to remove the piles of large, loose rocks at site and then smooth over. In the Spring of 2015, the Landowner will be working on an irrigation project on another tract of land nearby and will bring the dirt from that project and spread it over the area where the large rocks were removed. The Landowner will spread the dirt in the Spring. He also stated that because of the rocky nature of the Baldwin site, his crops have never grown there, just weeds and grass.
