Expedition Water Solutions respectfully requests that water samples not be required from the EWS 1A (05-123-39891) due to its proximity to the EWS #1 (05-123-39770). The bottom hole location of the EWS 1A will be approximately 3,960' from the EWS 1. The EWS 1 well aquired water samples in all the same formations as permitted for injection in the EWS 1A and no water samples obtained had a TDS of less than 10,500 mg/L.
