COMMENTS:

WPXENERGY is following up with a post vent summary for this wellbore. The surface bradenhead pressure has been shut in since July 2014 and has only built to 210 psi. Surface Casing shoe depth is 1430'. Hydrostatic Pressure at Shoe: 629 psi. Surface Pressure: 210 psi. Total Pressure at Shoe: 839 psi. Max allowable pressure on surface given .64 psi/ft gradient: 286 psi.

Since WPX is below the 286 psi max allowable pressure, we would like to leave the bradenhead shut in and continue monitoring.
