## No Further Action Required - Noble Energy Lilli Unit 10-6, 16-6 (P-6) Pit Closure (Remediation Project #8062, Weld County)

Jacob,

COGCC has reviewed the No Further Action Request submitted by Noble Energy, Inc. for the Lilli Unit 10-6, 16-6 (P-6) pit in Weld County (Remediation Project #8062, Pit ID #112030). Based on the information presented, it appears that no further action is necessary at this time, and COGCC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be significantly impacted, then further investigation and/or remediation activities may be required at the site.

Remediation Project #8062 has been resolved in COGIS and Pit Facility ID #112030 now has a "Closed" status.

The site must comply with the requirements of Rule 1003. for interim reclamation.

Note that an additional Pit Facility is present in COGIS, with the ID 118035. This pit shows Noble as the Operator and is called the RIM 10-6 & 16-6. Records in COGIS show that Diversified Operating submitted a Pit Permit for the RIM 10-6 & 16-6 in 1988. Walsh Production, Inc. assumed operation of these assets in 1994 and subsequently changed the lease name from RIM to Lilli in 1995 as seen on Document #253080. Based on this information, and a review a aerial photography dating to 1988, it appears that Pit #112030 was created as a duplicate to pit #118035 when Walsh submitted the required Pit Inventory in 1997. Therefore, COGCC has also changed the status of Pit ID #118035 to "Closed" in COGIS.
