By that time, as you advised me on the phone, you had already issued a violation notice. Then you hung up on me when I tried to let you know why it was so important for you to contact me prior to entering my property.

> I am available Monday morning from 8:00 until 10:00 should you wish to inspect the Katie Eileen wells. Please let me know what time you can be at my front gate and I will escort you to the wells. Should you suspect us of criminal activity, by all means, get a search warrant and have the sheriff escort you onto our place before then. We will not shoot at him or anybody he is escorting. If your purpose is truly to inspect the locations for adherence to COGCC rules and regulations then bring your note pad on Monday and you can write up all the deficiencies you find and we will address them to the best of our ability as soon as we can. If your intention is to run roughshod over our Constitutional rights then you should be prepared for a fight because I will defend my rights and my family to the death! Any questions?
