COMMENTS:

We believe this spike was due to completions team drilling out plugs on the well and thermal expansion. The completions team was in the process of RDMO when the surface casing alarm went off. The flow back crew hooked up to SC and blew well down to zero within minutes. We received all gas/air and no fluid. We believe this is isolated to thermal expansion and no mitigation is recommended at this time. The closest offset well being completed at the time was the NRC 3N-32HZ (123-39291).
