COGCC is reviewing the Form 2A for NGL C5, document number 400702651. In order to complete our review of this Form 2A, please respond via email regarding the following:

1. Under Related Remote Locations, this Form 2A appears to be associated with Form 2A doc number 400706275. With your concurrence, I will add the Related Form 2A document number.
2. Under Current and Future Land Use, Future land use is indicated as Dry Land and UIC Facility. According to the Facility Layout drawing, this does not appear to be a UIC Facility. With your concurrence, I will remove UIC facility from the Future Land Use section.
3. The Plant Community information does not need to be completed as under the Current and Future Land Use as land use is indicated as cropland. With your concurrence, I will remove the information under Plant Community.
4. Under the Water Resources section for Groundwater Baseline Sampling and Monitoring and Water Well Sampling, Rule 609 is listed. This particular location is in the Rule 318A Groundwater sampling area and not 609. With your concurrence, I will change Rule 609 to 318A.
5. In order for a timely review, in the future, please reference the 604.c.(2) rule applicable for each BMP.
6. Location pictures are not attached and are required with every Form 2A. Please send location pictures to attach to the Form 2A.
