#### COMMENTS:

High Plains Disposal respectfully requests an exemption from rule 325 C.1 for the Platteville #2 well due to its proximity to the Platteville #1, and #1's high water TDS analysis results. The bottom hole location of Platteville #2 will be approximately 2659' from Platteville #1. The Platteville #1 well acquired water samples from depths that contain all of the formations as permitted for injection in the Platteville #2 and no samples obtained had a TDS of less than 10,500 mg/L. Since the formation names slightly differ, attached is a comparison of the depths and formations between Platteville #1 & #2, including the TDS results from #1.
