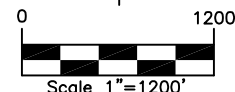

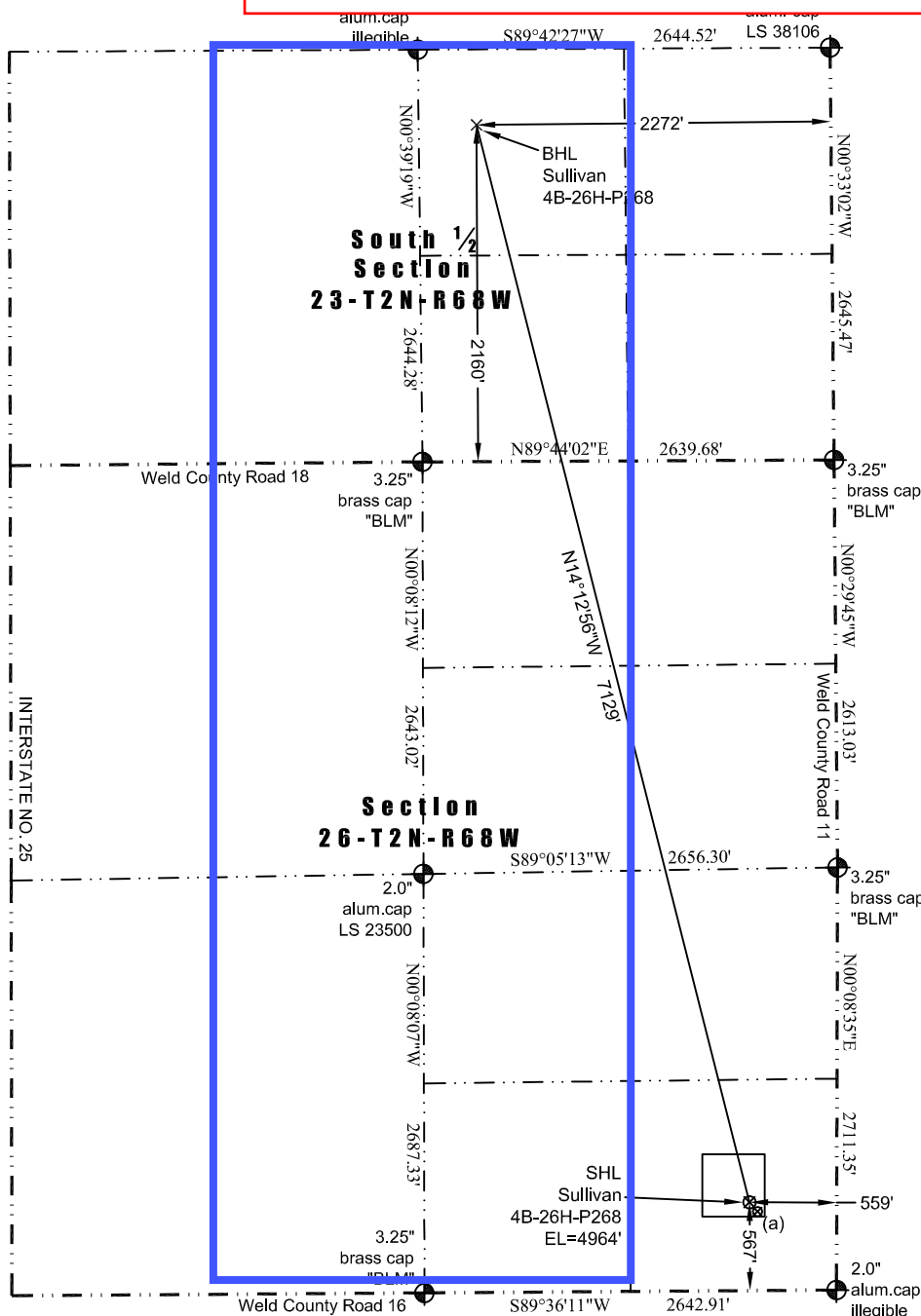

In accordance with a request from Jay Knutson of EnCana Oil & Gas (USA) Inc., Washburn Land Surveying, LLC has determined the location of the **Sullivan 4B-26H-P268** well site to be SHL: 567' FSL and 559' FEL, (BHL: 2160' FSL and 2272' FEL), as measured at ninety (90) degrees from the section lines of Section 23 and Section 26, Township 2 North, Range 68 West of the 6th Principal Meridian, Weld County Colorado.

Notes:

- 1) Bearings and distances based on NAD 83 Colorado North State Plane Coordinate, using RTK GPS observations taken 7/7/14 by operator Ryan Christi.
- 2) Conversion factor to ground (1.0002744738).
- 3) Elevations based on NAVD 88 GPS heights and Geoid 2009 corrections.
- 4) See Location Drawing for visible improvements within 500 feet of Pad Site.
- 5) The surface use is a cultivated field.
