Per your request attached are photo of the backfilled area from the historic release at the subject site. As we discussed the Form 27, manifests and accompanying information were submitted on August 5, 2014. The Landowner was contacted to sign a letter relinquishing Magpie from vegetating the area due to planting scheduled in the spring, but the landowner was upset about other issues. As the impacted soils have been characterized and removed; and the surface has been backfilled to match grade, Magpie would like to request NFA with regards to the soil remediation #8281 pending final approval from the landowner regarding the vegetation of the area.
