From separator two 3" fiberglass pipelines lines approximately 150' to one (1) 300 bbl oil tank and one (1) 300 bbl water tank. Production equipment at the Aloha Mula # 10 tank battery shared with Aloha Mula # 9,10,11,12 wells.
