Bonanza Creek Energy, Inc. believes there is enough risk and unknowns in radically combining these concepts that Bonanza Creek Energy, Inc. would be at a disadvantage to our competitors should we not be allowed the minimalist protections provided by withholding key information for the proscribed confidentiality period. These wells are evaluating a new density for this area in the Niobrara formation utilizing discrete benches and a new spacing pattern. The effects on drilling and completion operations are not well known for this particular configuration and warrant further study.
