The producing lateral for the Mojack N-28HN is extending another mile to the south than what was previously permitted. The Surface Hole Location has not changed, nor has the Top of Productive Zone changed. The well will now have a Bottom Hole Location in Section 33, Township 7 North, Range 64 West. New Mineral Owner Notifications were mailed out on October 14, 2014 and were recieved by all Mineral Owners on or before October 28, 2014. Bayswater has received verbal and written acknowledgement from all Mineral Owners within the Proposed Spacing Unit all of whom have no objections.

Operator intends to drill the well to the Niobrara formation at 16,869' MD and 7,020' TVD.
