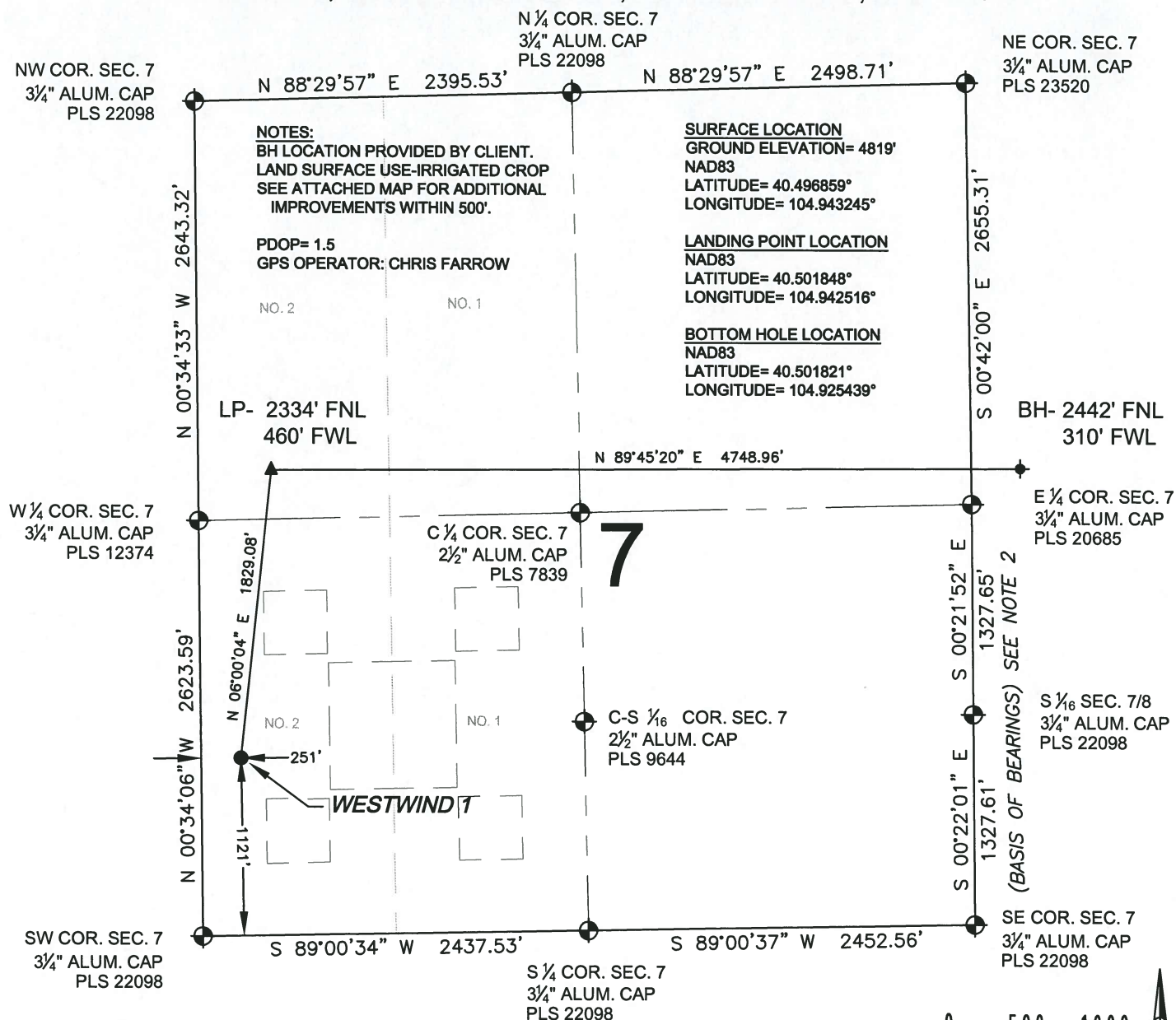


WELL LOCATION CERTIFICATE: WESTWIND 1

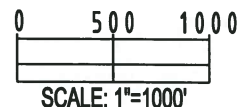
