#### COMMENTS:

PDC moved to the well to perform an MIT,found casing leaks prior to start of test. Set a Retrievable Bridge Plug and then ran a packer to isolate the production casing leak. Found holes between 1990'-3517'. PDC pulled the RBP and set a CIBP at 6728' which is 32' above the top perforation with 2 sacks cement on top. PDC engineering currently evaluating plans to repair or plug the well will submit plans prior to 12/18/2014.
