## COMMENTS:

Red River Ranch Holdings LLC (RRR) is both the owner and operator of Red River Ranch. RRR is closing Pond D (the subject facility), a pond that is part of RRR's centralized E&P waste management facility. RRR has submitted a Form 27 describing the planned closure approach, which includes leaving Pond D as a functioning pond (after removing the liner) and not restoring the site to its pre-construction contours. The pond is located in a natural drainage and periodically retains a small amount of natural runoff that is of benefit to small mammals and birds. The pond also contributes to improved water quality in Lorencito Canyon below the pond by retaining sediments that would otherwise contribute to undesirable suspended solids in the stream. In this Form 4, RRR is seeking COGCC approval of a variance exempting it from the requirements of Rule 1001.a to restore the land to its preconstruction condition and a variance from the preliminary closure plan contained in RRR's application for a centralized E&P waste management facility permit. That preliminary closure plan contained provisions to re-grade the pond walls and restore pre-construction contours.
