Environmental	1) There is a problem in the COGCC e-form system. Repeatedly, operators have submitted attachments that get lost in the process and do not show up in the e-forms. For that reason, it has been agreed with Encana that they submit also and separately the attachments as pdf, by email. The attachments have been reviewed and will be uploaded to the database. 2) COGCC is in agreement with the disposal of cuttings (that are in compliance with Table 910-1) in the onsite vault (excavation on the cut side of the pad).
