S½SE¼ of Section 9, Township 5 North, Range 65 West
S½S½ of Section 10, Township 5 North, Range 65 West
Containing 240 acres more or less

Bayswater is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(5). 

WELL ARELLANO S-10-9HN TO BE LOCATED 1509' FSL AND 330' FEL, SEC. 10, T5N, R65W


