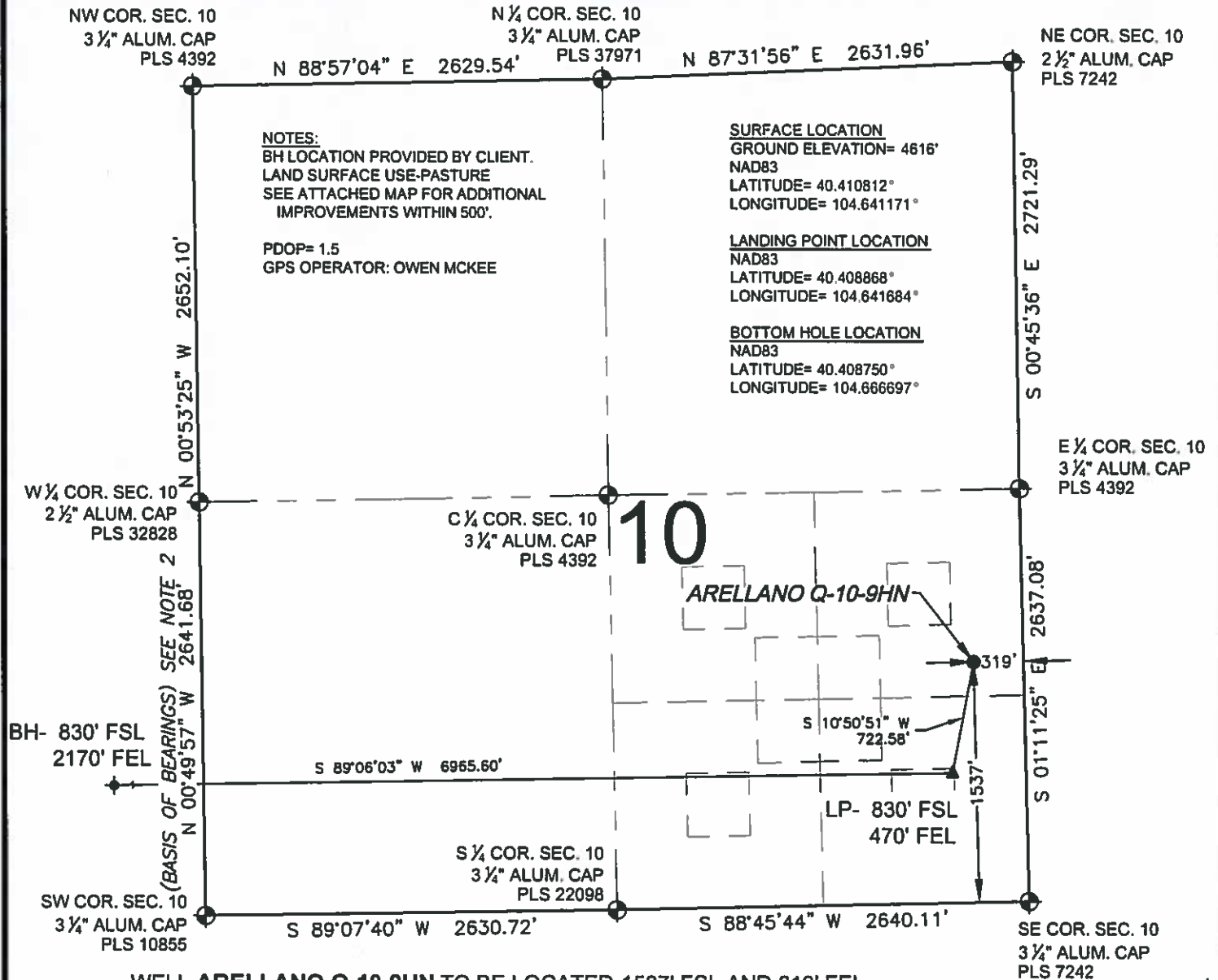


# WELL LOCATION CERTIFICATE: ARELLANO Q-10-9HN

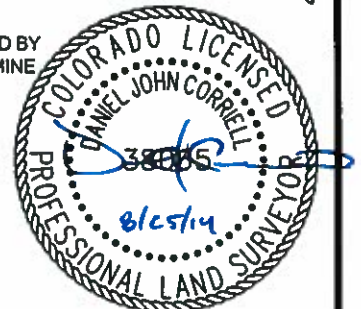

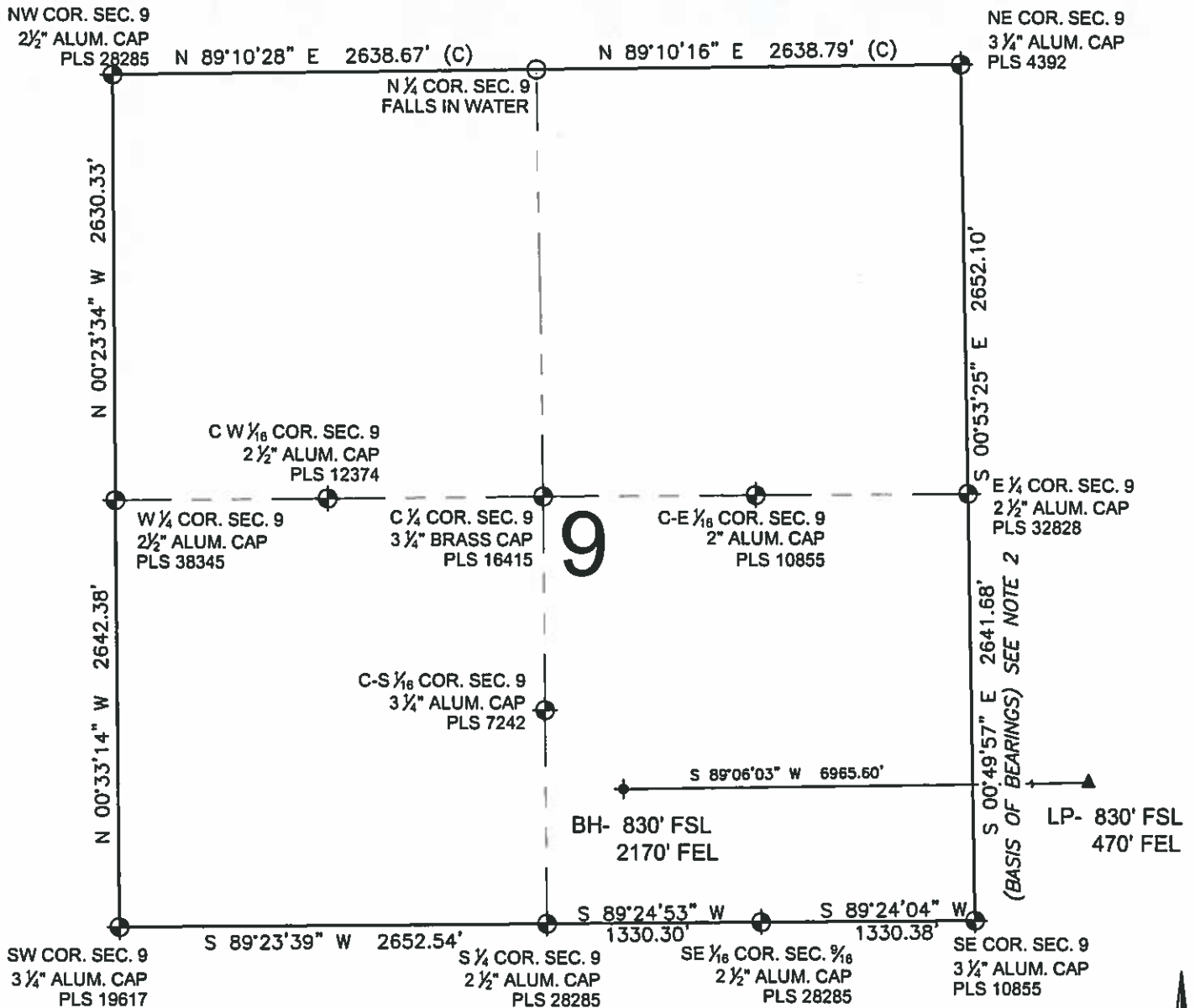
