Cased-hole neutron and gamma ray logs will be run to describe the stratigraphy of the entire wellbore and to adequately verify the setting depth of surface casing and aquifer coverage. On a multi-well pad (loc #420621) these cased-hole logs will only be conducted on one of the first wells drilled on the pad. The Drilling Completion report - form 5 for every well on the pad will identify which well was logged.
