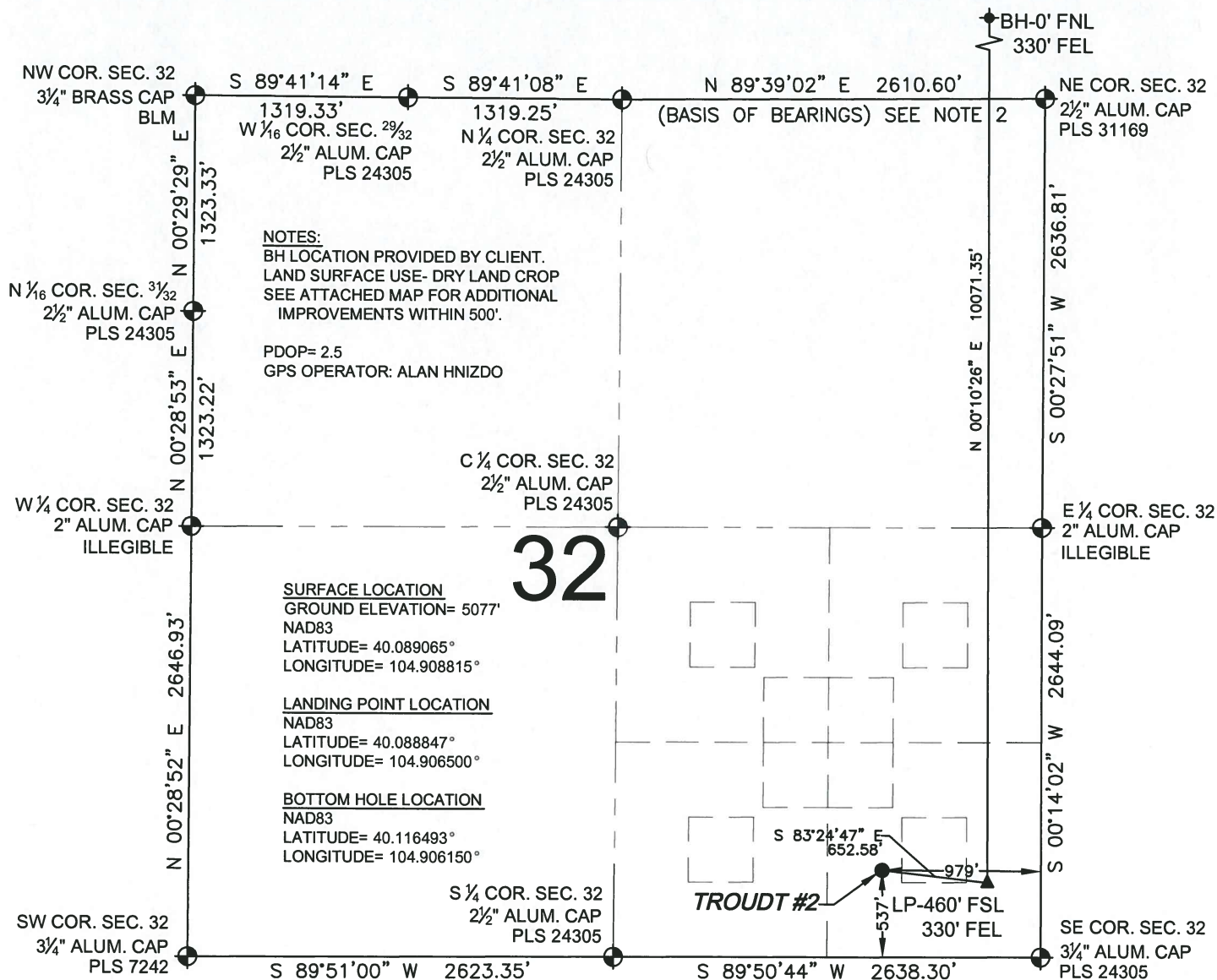


WELL LOCATION CERTIFICATE: TROUDT #2

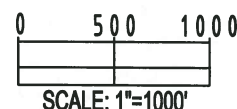
- = EXISTING MONUMENT

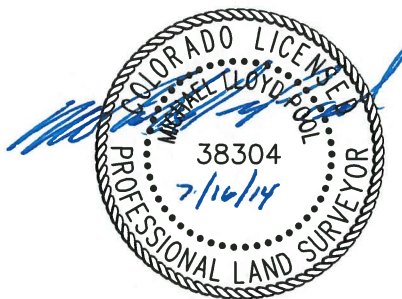
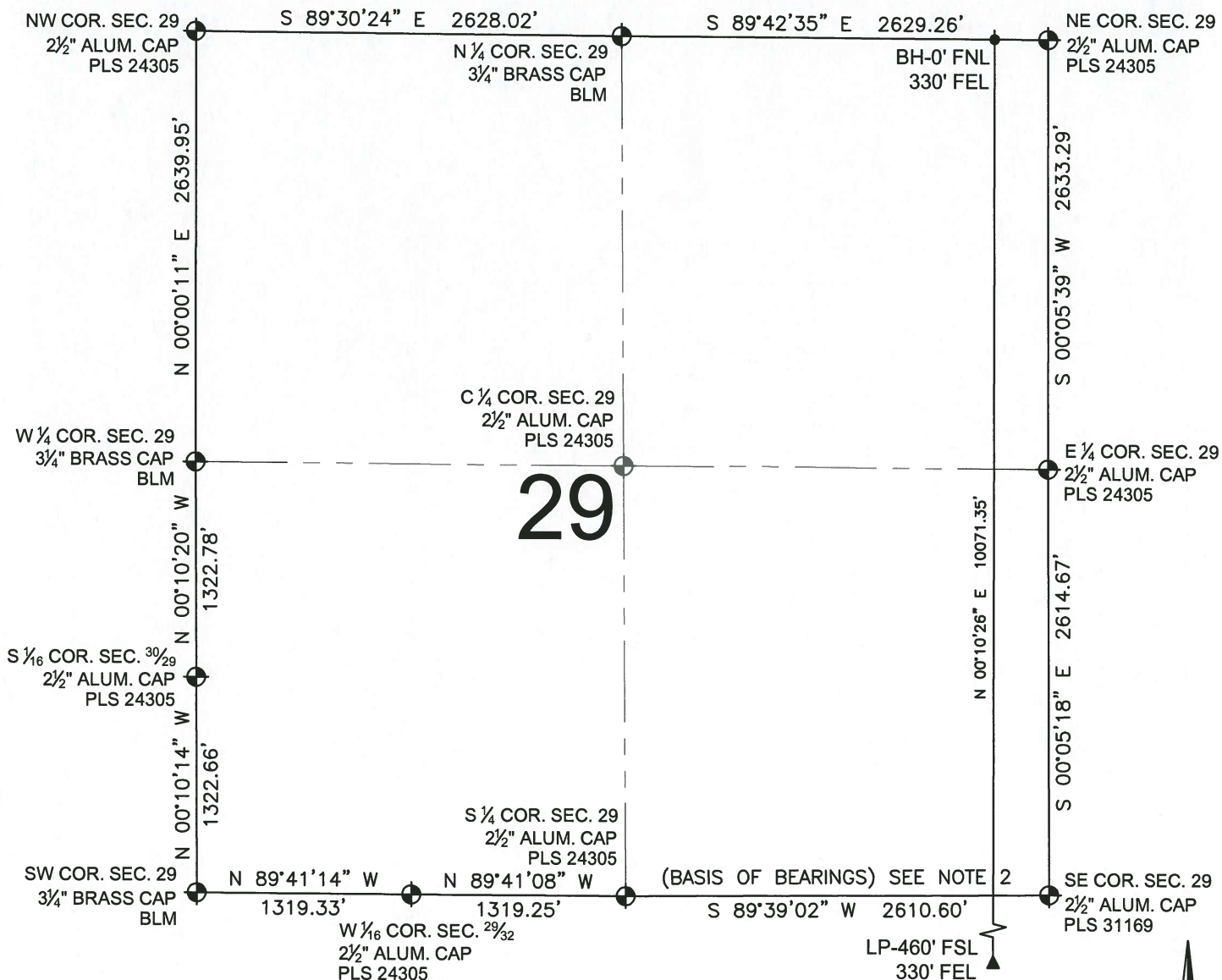
