Due to ongoing contract negotiations with the subcontractor responsible for collecting samples associated with Project Rulison, the required sample from the Battlement Mesa 36-13B well was not collected during the fourth quarter of 2014. To date, laboratory analytical results have been non-detect for the required analytes at this sampling location.
