#### COMMENTS:

LINN Energy plans to use a water based, low solids, non-dispersed mud system with a 3-4% bio-diesel additive to drill the production hole after setting and cementing surface casing.  
This will provide lubricity to reduce torque and drag and aid in shale inhibition.

Our best practices for cuttings are listed below:

Cuttings Management: During drilling, LINN will keep the drill cuttings segregated on the well pad. Cuttings will not be in contact with fill material or topsoil on location. After drilling and completion operations have been completed, soil amendments such as phosphorus and nitrogen will be utilized to expedite the amendment process (if necessary). On pads where a drilling pit is present, cuttings will be used in the backfilling of those pits. On pads where no drilling pit is present due to closed-loop drilling, amended cuttings that meet the Table 910-1 levels are spread on location with topsoil and seeded as part of reclamation activities.
