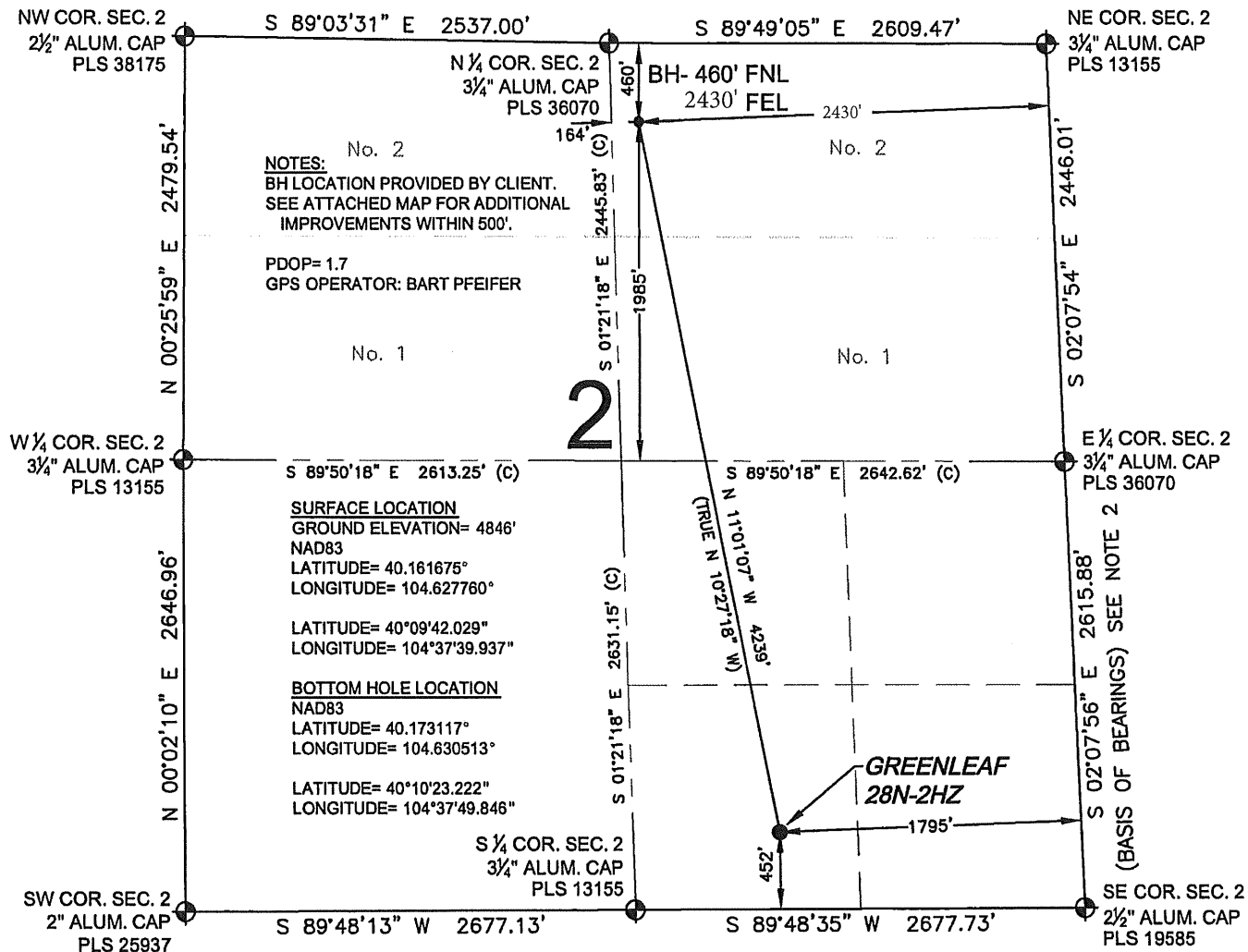


WELL LOCATION CERTIFICATE: GREENLEAF 28N-2HZ

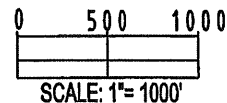
