#### COMMENTS:

This well had communication to the Surface Casing while attempting to frac, we shut down and bled off the casing on the frac job. We pressure tested the casing and concluded we have a collar leak above 50' in the 7" casing. We are in the process of running a 4 1/2" tie-back casing string to isolate the 7" casing from any frac pressures.
