In response to Inspection No. 675200957, Encana Oil and Gas (USA) Inc. will address the rutting at wellhead present on the PP20 location as soon as practicable after the spring 2015 thaw & run-off. Encana currently uses the following natural BMPs on location to minimize surface rutting & degradation: perimeter berm and associated diversion ditches to prevent run-on, pad surface has been compacted, graveled and graded to sheet any water away from the working surface & driving areas.

Encana will continue to inspect the location and make necessary improvements to the existing surface BMP's currently in use on the location until weather conditions allow for a more comprehensive assessment.

As requested in the inspection, Encana is submitting site-specific BMP's that are appropriate for this location given its geographical considerations and to accommodate the rutting this location receives, especially during the winter season.
