It is currently uneconomical to produce this well due to facility processing constraints. If economics improve this well will be returned to active production. This well is isolated from the atmosphere by closed valves on the wellhead assembly, two closed gate valves to isolate the casing and one closed master valve to isolate the tubing. A isolation packer is set in the casing downhole at 5573.9'
