- 2) Kill well and unflange wellhead.
- 3) Unland tubing. POOH, stand back 2 3/8" tubing.
- 4) RIH w/ RBP. Set RBP @ +/- 6546' spot 2 sx of sand on top of RBP.
- 5) Pressure test casing to 1500 psi, hold pressure for 30 minutes
  - a) If casing pressure holds, bleed off and continue with procedure below
  - b) If casing pressure does not hold, contact Joe Brnak (970)381-1234 and AJ Paine (406)671-4612
- 6) Bleed off Bradenhead, unland casing. If unable to unladn csg, contact JoBrnak (970)381-1234 and AJ Paine (406)671-4612
- 7) RIH with 1 1/4" down annulus to 1896'
- 8) Condition Hole
- 9) Pump 50 sx cement (+/- 175 feet of cement)
- 10) POOH with workstring, reland casing
- 11) WOC 4 hours. Run CBL
- 12) Clean out hole, retrieve RBP @6722', POOH
- 13) Test in hole with 2 3/8" tubing, notched collar, SN. Replace joints as needed.  
Land with SN nipple at +/-6842' (18' above Codell perfs)  
Ensure we are clean to at least 6925', either tag and wash or run sinker bar.
- 14) Land tubing, flange up wellhead
- 15) RDMO, RWTP
