Noble received access to sample water well(s) 3659333, 9062611, 9062610, C620435 on 1/12/2015. However, the landowners' irrigation wells to be sampled have been shut in for the winter. Noble sent Post cards requesting access to the remaining 21 qualified water wells within quarter sections within a 1/2 mile of this location were mailed to the landowner(s) on 1/19/2015. Noble has not received access at this time. The first well on the pad (Colt A13-625) is set to be spud on 1/29/15.
