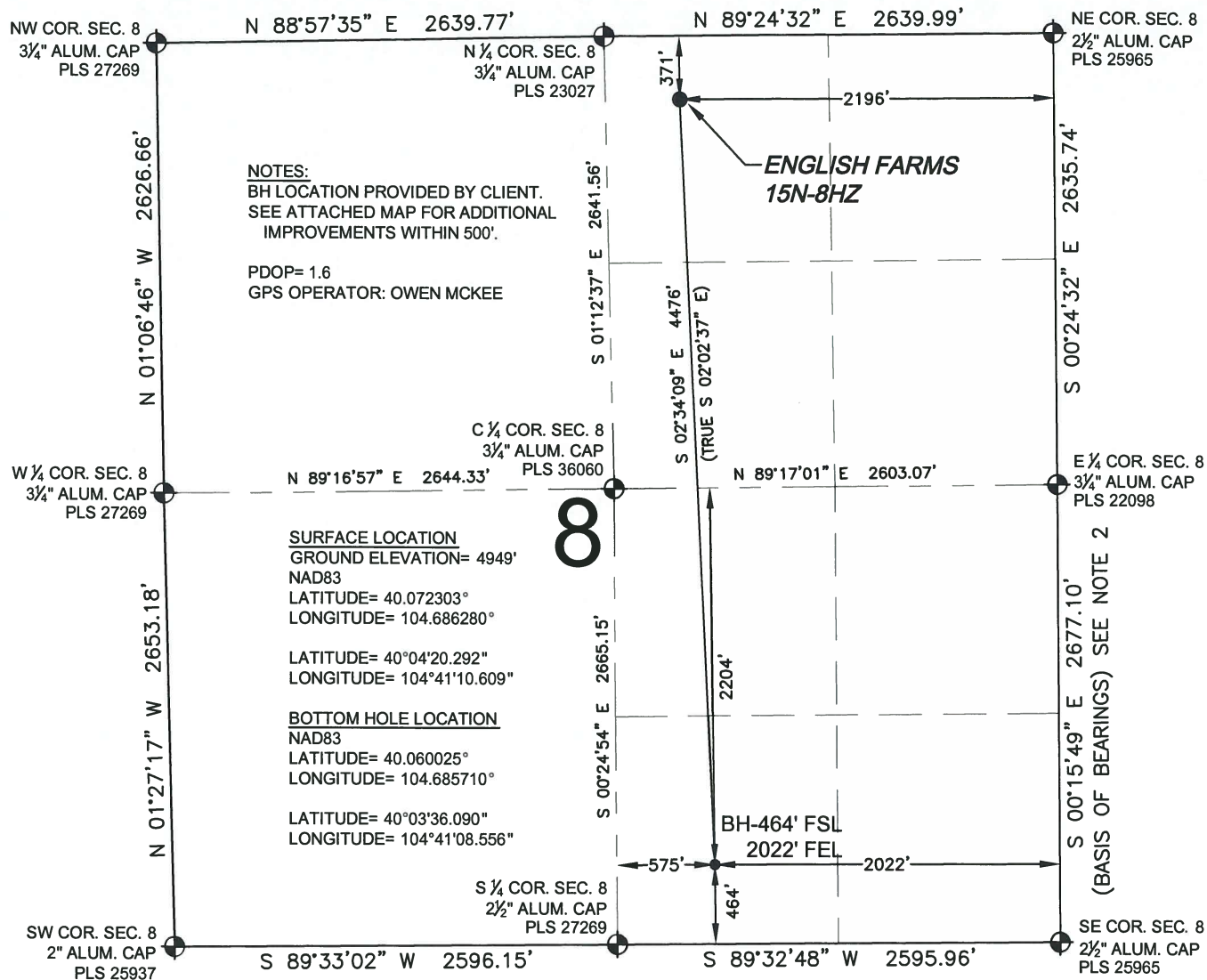


# WELL LOCATION CERTIFICATE: ENGLISH FARMS 15N-8HZ

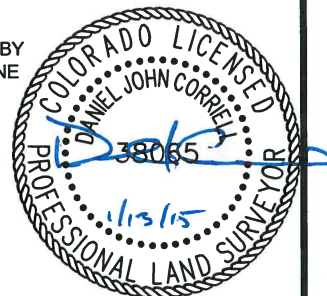
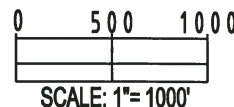
- = EXISTING MONUMENT    ◆ = BOTTOM HOLE
