The historical impact was caused by an old produced water pit and buried produced water tanks. With COGCC's permission, confirmation samples will be analyzed for TPH, BTEX, PAHs, EC, SAR, and pH and the background sample would be analyzed for EC, SAR, and pH. The samples will not be analyzed for metals.
