Operator Comments:

In response to Inspection No. 675201043, Encana Oil and Gas (USA) Inc. has reviewed the corrective action items "lines and concrete pad, remove per COGCC rules" & "location is rutted at tank containment. - Use BMPs to address" for LOCATION ID #324378.

In regards to the first corrective action item mentioned above, the lines and concrete pads were utilized by an onsite compression unit which was installed at this location. Encana Oil and Gas (USA) Inc. is currently evaluating the production potential at this location, and whether the need for onsite compression will be required in the future. Encana requests that the lines and concrete pads remain on location until the production requirement for the compressor unit has been determined. If onsite compression is not necessary, the lines and concrete pads will be removed to satisfy the corrective action. By leaving the lines and concrete pads on location, Encana would reduce any unnecessary surface disturbance that would occur if the compression unit were to be deemed necessary for production operations, and reinstalled at this location.

Regarding the second corrective action item above, the use of BMPs to address rutting on location at the tank containment, Encana Oil and Gas (USA) Inc. will address the rutted area present on location near the tank containment as soon as practicable after the spring 2015 thaw and run-off. Specifically, after spring run-off and the location surfaces dry, Encana will use general blading on the location to eliminate ruts. Additionally, Encana will inspect the location and make necessary improvements to the existing surface BMP's currently in use on the location.
