(2), an Operator may rely on water sampling analytical results obtained from an Available Water Source within the sampling area provided: The previous water sample was obtained within the 18 months preceding the initial sampling event required pursuant to subsection d.(1)" The water sample from COGCC Facility ID# 752924 was collected within 18 preceding the drilling of the Razor 21 SWD 1 well.

AGW was prepared to sample a stock well permitted to Nelson Ranches, Inc (DWR Permit #11399). AGW staff met Mr. Gene Nelson at his house, went over the access agreement, and he then accompanied AGW to his ground water well to be sampled. Mr. Nelson attempted to turn on the electric to the well, but upon further inspection, realized that utility work that had recently been completed neglected to reconnect his power so the well was inoperable; no sample was collected.
