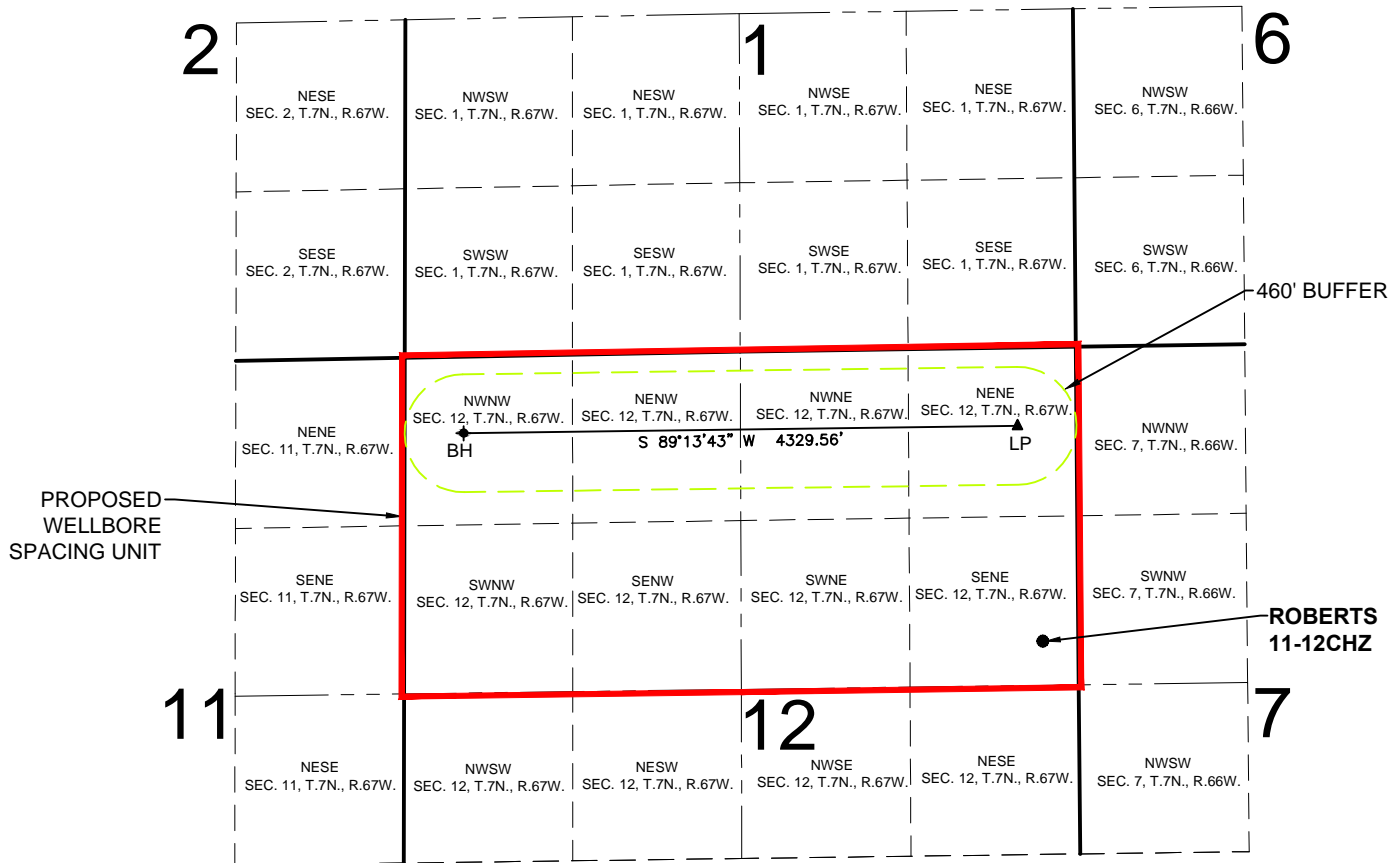

SURFACE LOCATION

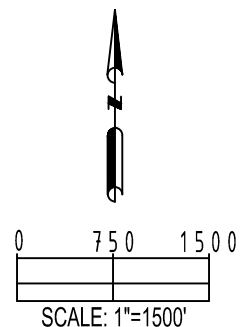
