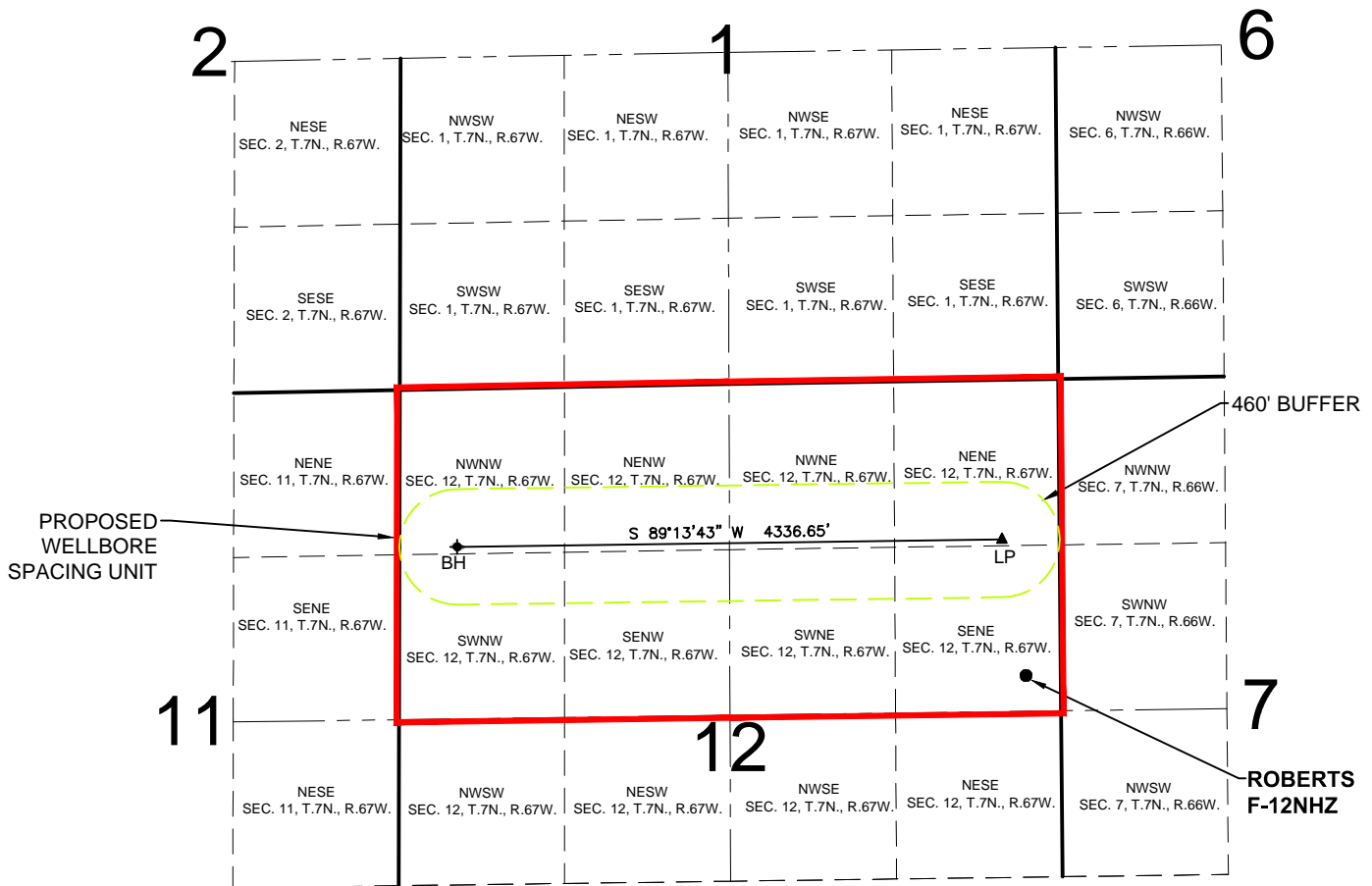

SURFACE LOCATION

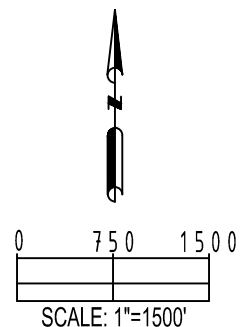
